## 2022 STORAGE AGREEMENT

This Storage Agreement is entered into between Eastern Bay Yachting Center / Maritime Enterprises and the boat "Owner". In consideration of the terms and conditions herein, Eastern Bay Yachting Center/ Maritime Enterprises does hereby agree to store the owner's boat and/or trailer at 1804 Crab Alley Drive Chester MD 21619. Eastern Bay Yachting Center reserves the right to revise any part of this agreement.

- 1) **TERM.** The term of this Agreement shall commence as of the date the boat arrives and all terms and conditions of this Agreement shall continue in full force and effect so long as the boat remains on the property.
- 2) **HAULING.** No boat will be hauled into storage without a signed storage contact, credit card on file and proof of insurance.
- 3) **BOAT COVERS.** Are permitted during winter or storm storage. Boats may be shrink-wrapped or left open. Eastern Bay Yachting Center / Maritime Enterprises is not responsible for any missing or torn covers.
- 4) **BOAT STANDS.** Owners are NOT allowed to move or adjust the boat stands, chains, or blocks.
- 5) **TRAILER STORAGE.** Owners are responsible to prepare their own trailer for storage. Eastern Bay Yachting Center / Maritime Enterprises is not responsible for damage to trailers due to acts of god or theft. It is the owner's responsibility to tag and keep the trailer in working condition.
- 6) **OWNER'S RISK OF LOSS.** No ailment is created by this Agreement. The exclusive care, custody and control of any and all boat and personal property stored on the premises shall remain vested in the Owner, and all property located at the facility by anyone shall be stored at the Owner's sole risk. Eastern Bay Yachting Center / Maritime Enterprises agents and employees shall not be liable for loss of or damage to, any person property while at the rented premises including, but not limited to, burglary, mysterious disappearance, fire, water damage, rodents, Acts of God, or the active or passive acts or omissions or negligence of the Owner, Owner's agents or guests. Owner, at owner's expense, shall secure its own insurance to protect itself and its property against all perils of whatsoever nature. Eastern Bay Yachting Center / Maritime Enterprises does not maintain insurance for the benefit of the boat owner, which in any way covers any loss, or claim whatsoever. Owner will indemnify and hold Eastern Bay Yachting Center / Maritime Enterprises harmless from and against any and all manner of claims for damages or lost property or personal injury.
- 7) **RIGHT TO MOVE.** Eastern Bay Yachting Center / Maritime Enterprises reserves the right to move said boat, trailer, and/or personal property within the premises of 1804 Crab Alley Drive Chester MD, 21619 without giving prior notice to the owner. Boats, trailers, and personal property shall remain at all times in movable condition.
- 8) **NOTICES AND CHANGES.** Owner agrees to give Eastern Bay Yachting Center / Maritime Enterprises prompt written notice to of any change in his or her address and/or contact information and any change in ownership of the boat in storage. Responsibility will remain with the original owner until new agreement is signed.
- 9) **ADDITIONAL CHARGES.** Owner agrees to additional storage charges if the boat and/or trailer is left on land past the date of which winter storage/ land storage ends. These additional storage charges are to be determined.
- 10) **FAILURE TO PAY.** If I fail to pay for the above completed services, I understand Eastern Bay Yachting Center shall have a mechanic's lien upon the vessel to secure payment for the services and I expressly waive all rights to claim exemption under the state laws.
- 11) **COLLECTION.** If collection is made by a suit or any other method required, I agree to pay interest of 23%APR until paid in full, including collection and reasonable attorney fees.
